Since you resided here for 15 years in the 50's, 60's and 70's, and that I was a relief houseparent with you under my "care", a lot of things can be said but there is insufficient time to say too much. But you know how I feel about you.

First of all I want to thank you for the generous manner in which you have support the ministry of CCH financially. You have been one of our top donors for many years, and it has been through contributors like you that we have been able to serve some very seriously disturbed young people in recent years who would not have had a chance otherwise. I also know that your financial support came from the heart because you can say that you have "been there". Thank you for your support.

When I first came to CCH in 1969, fresh out of college, to work as a staff member, you became one of my boys. As an immature and selfish 15 year-old young man you thought you knew everything even though you probably felt scared inside. I also felt like I knew everything and I felt scared inside. Now after we were reconnected after I came back to work at CCH in 1986, I can see how God has worked in your life in the intervening years.
